Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2022-23 educational progress for Iron Mountain High School. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. If you have any questions about the AER, please contact Principal Amy Galvan for assistance.

For the 2022-23 school year, schools were identified based on previous years' performance using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that had at least one underperforming student subgroup in 2022-23. An Additional Targeted Support (ATS) school is one that had a student subgroup performing at the same level as the lowest 5% of all schools in the state in 2022-23. A Comprehensive Support and Improvement (CSI) school is one whose performance was in the lowest 5% of all schools in the state or had a graduation rate at or below 67% in 2021-22. Some schools are not identified with any of these labels. In these cases, no label is given.

Our school was identified as a '**HAS NOT BEEN GIVEN ONE OF THESE LABELS**' status.

Key challenges for Iron Mountain High School are a lower percentage of students who take the SAT that meet or exceed the benchmark score in both Evidence Based Reading/Writing and Mathematics. In addition, truancy rates and chronic absenteeism is also a major impact on the students progress.

The key initiatives that Iron Mountain High School is focusing on are with the intent to improve overall student performance in both the ELA and Mathematics areas. Those initiatives are as follows;

- Multi-Tiered System of Supports (Academically)
- Offering to make up time with attendance
- Peer tutoring
- After School Homework hour
- Credit Recovery
- Online Courses
- Staff Professional Development

State law requires that we also report additional information.

- 1. PROCESS FOR ASSIGNING PUPILS TO THE SCHOOL-** All students who are in grades 9-12 who live in the City of Iron Mountain will attend Iron Mountain High School unless the School of Choice option is selected.
- 2. THE STATUS OF THE 3-5 YEAR SCHOOL IMPROVEMENT PLAN-**Iron Mountain School District and Iron Mountain High School are in compliance with the Michigan guidelines for school improvement. In 2022-2023, Iron Mountain High School continues to implement the School Improvement Plan, which is reviewed and updated annually.
- 3. A BRIEF DESCRIPTION OF EACH SPECIALIZED SCHOOL-** Iron Mountain High School offers in-person classroom instruction, online courses, and Credit Recovery. In addition, Iron Mountain Public schools offers an Online Partnership program that allows for an online instructional program for families that are seeking a virtual format for their high school students.

The core curriculum follows the Michigan guidelines and is followed in its entirety. There are no variances from the state’s model.
