Reconfirm how instruction (Return to Learn Plan) is going to be delivered during the 20/21 school year:
 (Recommendation: Explain in narrative form any modifications to the original Extended Learning Plan)

This month's plan has been updated briefly. Starting with the second semester distance learning for the 9-12 students will only be allowed for those students testing positive and/or need to quarantine for -19 reasons. Instruction is currently being offered in person, through distance learning, through Virtual Learning, and through Virtual Learning with Extended Learning Opportunities, which are offered one time per week. Teachers are continuing their work through the curriculum for both core and non-core classes while integrating classroom and local assessments and progress monitoring techniques in an effort to identify and reduce learning gaps as well as ensure students are meeting their academic goals for the year. IMPS will continue to review COVID-19 data with our local health department and make decisions that best match our students, staff, and family's educational and safety needs. We will temporarily shift from face-to-face to virtual learning when requested by our health department if the data indicates the need.
