Reconfirm how instruction (Return to Learn Plan) is going to be delivered during the 20/21 school year:

(Recommendation: Explain in narrative form any modifications to the original Extended Learning Plan)

We have added one modification to our original ELP. Under this modification students in grades 9-12 will be allowed to extend their distance learning option for a temporary time period. Students and parents will have to make arrangements with teachers and the building principal and have a return to school date listed. Students will be expected to be in a safe learning environment and if administration determines students are not at home or in a safe environment, the distance learning option will be removed for that student. This student will then be expected to be in school or consequences regarding grades and attendance may be imposed. Students and parents will also be advised that at times while the student is distance learning, they may be asked to come into the building for quizzes/tests/projects/ etc. Otherwise, instruction is currently being offered in person, through distance learning, through Virtual Learning, and through Virtual Learning with Extended Learning Opportunities, which are offered one time per week. Teachers are continuing their work through the curriculum for both core and non-core classes while integrating classroom and local assessments and progress monitoring techniques in an effort to identify and reduce learning gaps as well as ensure students are meeting their academic goals for the year. IMPS will continue to review COVID-19 data with our local health department and make decisions that best match our students, staff, and family's educational and safety needs. We will temporarily shift from face-to-face to virtual learning when requested by our health department if the data indicates the need.
