K-12 Title IX Policy and Training Package

On May 6, 2020, the U.S. Department of Education issued new Title IX regulations. The regulations, which took effect August 14, 2020, significantly change schools' obligations when addressing sex-based harassment and discrimination complaints. Thrun Law Firm has developed a model Title IX package to assist K-12 schools with meeting the new Title IX requirements. The Package consists of a model Board Policy for K-12 schools, a sample formal complaint form, a sample investigation report form, template notice letters, template mandatory and permissive dismissal letters, a template determination of responsibility, and an optional recordkeeping protocol. We believe the package complies with the new federal Title IX regulations.

The policy package will be personalized with your school's name.
